The meeting was called to order at 6:30 pm by Marshall Hogue, HOA President.

- 1. A basic meeting agenda and the financial report up to today's date were distributed to attendees. The following agenda was addressed:

 - A review of 2020 accomplishments and wish list for the community Marshall Hogue

- Financial Report Lexington Place currently is projected to have \$44,217 in reserves at the end of
 the calendar year. Due to unbudgeted expenses incurred due to the pool, pond fountains, pond
 maintenance, the storage area gate, and the delinquency of 12 properties, we are about \$9,200
 above the year's projected expenses.

This year we have about a 94% collection rate for HOA association fees. We are actively working to collect the dues from all homeowners in arrears.

Due to increased monthly expenditures, primarily associated with the pool and the ponds, we will eventually use up all our reserves over time because the cash generated by the collection of dues is less than what is required to keep the subdivision running. Thus, the board voted to raise the dues to \$425 for calendar year 2021.

3. 2020 Accomplishments:

- All street and pool lighting were upgraded with energy efficient LED bulbs
- The lighting at the entrance was improved to aid in the capturing of license plates on video
- Ponds were cleaned up; both in appearance and health
- The tennis court is once again functional
- The front entrance was power washed
- The pool deck was power washed and repairs to the pool building are still proceeding
- Through enforcement of covenants, several fences were repaired or replaced, and lawns improved

4. Election of the 2020 Nominees:

Note: We did not receive a single new nominee for the three expiring board member terms.
